

**TOWNSHIP OF MILLBURN
ORDINANCE NO. 2478-17
AN ORDINANCE DESIGNATING THE NEW STREET
“TOWN HALL PLAZA” IN THE TOWNSHIP OF MILLBURN,
ESSEX COUNTY, NEW JERSEY**

Statement of Purpose: *The purpose of this Ordinance is to create a name for a newly-created street named Town Hall Plaza which will connect Essex Street and Millburn Avenue.*

WHEREAS, the Township of Millburn has presently undertaken construction in connection with its “Complete Streets” Project; and

WHEREAS, N.J.S.A. 40:67-1(k), provides that the governing body of a municipality may make, amend, repeal and enforce ordinances to provide for the naming of streets within such municipality; and

WHEREAS, Phase I of that Project has resulted in the construction of a newly-created street to be designated “Town Hall Plaza” in the Township of Millburn, Essex County, New Jersey; and

WHEREAS, this street name designation shall affect the entire newly-created street of Town Hall Plaza from Essex Street to Millburn Avenue; and

WHEREAS, the Millburn Post Office shall be notified of such newly-created street by provision of a copy of this Ordinance; and

WHEREAS, the Millburn Police Department and Millburn Fire Department shall likewise be notified of such newly-created street by provision of a copy of this Ordinance; and

WHEREAS, the Millburn Township Engineering Department shall be notified of such newly-created street by provision of a copy of this Ordinance in order to enable compliance with Section 15-6.1 of the Revised General Ordinances of the Township of Millburn, which imposes a duty upon the Township Engineer to keep a record of all streets and public roads in the Township;

WHEREAS, appropriate signage shall be installed to reflect the street name; and

WHEREAS, a copy of this Ordinance together with a map showing the location of Town Hall Plaza shall be filed in the Office of the Essex County Register in accordance with N.J.S.A. 40:67-2.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF MILLBURN that the following street name is hereby designated as delineated below:

Section 1.

The name Town Hall Plaza shall be given to the newly-created street completed as a result of Complete Streets Phase I and running between Essex Street to Millburn Avenue.

Section 2.

The Millburn Township Post Office shall be notified of such newly-created street by provision of a copy of this Ordinance.

Section 3.

The Millburn Township Police Department and Millburn Township Fire Department shall likewise be notified of such newly-created street by provision of a copy of this Ordinance; and

Section 4.

The Millburn Township Engineering Department shall be notified of such newly-created street by provision of a copy of this Ordinance in order to enable compliance with Section 15-6.1 of the Revised General Ordinances of the Township of Millburn, which imposes a duty upon the Township Engineer to keep a record of all streets and public roads in the Township.

Section 5.

Appropriate signage shall be installed to reflect the newly-created street.

Section 6.

A copy of this Ordinance together with a map showing the location of Town Hall Plaza shall be filed in the Office of the Essex County Register in accordance with N.J.S.A. 40:67-2.

Section 7.

This Ordinance shall become effective immediately after adoption and publication according to law.
