

**TOWNSHIP OF MILLBURN
ORDINANCE NO. 2489-17
ORDINANCE TO AMEND AND TO REPEAL CERTAIN SECTIONS IN
CHAPTER VII "TRAFFIC" OF THE REVISED GENERAL ORDINANCES OF
THE TOWNSHIP OF MILLBURN**

STATEMENT OF PURPOSE: *The purpose of this Ordinance is to revise Sections in Part I "On Street Traffic Regulations" pertaining to permitted parking on and along Taylor Street and to make uniform, the Township's parking requirements on Taylor Street.*

BE IT ORDAINED by the Township Committee of the Township of Millburn in the County of Essex and State of New Jersey, as follows:

Section 1. Article VII entitled "Traffic", Part I entitled "On Street Parking Regulations", Section 7-11 entitled "Parking Time Limited On Certain Streets" is hereby amended as follows:

- a. Section 7-11.1 entitled "Time Limit Parking" and particularly, the following provisions thereof concerning only Taylor Street are repealed in their entirety:

<i>Name of Street</i>	<i>Side</i>	<i>Time Limit</i>	<i>Hours</i>	<i>Location</i>
Taylor Street	South	3 Hours	8:00 a.m. - 6:00 p.m.	From Main Street to Spring Street
Taylor Street	Both	3 Hours	8:00 a.m. - 6:00 p.m.	From Main Street to Spring Street
Taylor Street	South	3 Hours	8:00 a.m. - 6:00 p.m.	From a point 172 feet westerly of Main Street to Main Street

Section 2. Article VII entitled "Traffic", Part I entitled "On Street Parking Regulations", Section 7-13 entitled "Parking Prohibited At All Times On Certain Streets" is amended and supplemented as follows:

<i>Name of Street</i>	<i>Side</i>	<i>Location</i>
Taylor Street	a. Southerly	220 Feet Westerly of Main Street to 300 feet Westerly of Main Street

Section 3. Article VII entitled “Traffic”, Part I entitled “On Street Parking Regulations”, Section 7-14 entitled “Parking Prohibited During Certain Hours on Certain Streets and particularly, the following provision concerning only Taylor Street is amended and supplemented to substitute “300 feet westerly” for the current “172 feet westerly”, as follows:

<i>Name of Street</i>	<i>Side</i>	<i>Hours</i>	<i>Location</i>
Taylor Street	Southerly	8:00 a.m. to 6:00 p.m. Monday to Friday, Inclusive	Between Spring Street and a point 300 feet westerly of Main Street

Section 4. The provisions of this ordinance are severable and the invalidity of any phase, clause or part of this ordinance shall not affect the validity or effectiveness of the remainder of the ordinance.

Section 5. This ordinance shall take effect after final passage and publication as required by law.
