**NOTICE** is hereby given that sealed bids will be received by the Township of Millburn, in the County of Essex, State of New Jersey, at the office of the Township Clerk, Millburn Town Hall, 375 Millburn Avenue, Millburn, New Jersey, 07041 (ATTN: Christine Gatti, Township Clerk) on or before THURSDAY, OCTOBER 24, 2019 at 11:00a.m. prevailing time or as soon thereafter as the matter may be reached, for **“Parsil House ADA Restroom Renovations”** in accordance with the Specifications and Information to Bidders provided by the Township. At that time and place, such bids will be publicly opened and read aloud. No bids shall be received other than at the time and place herein designated for their receipt, unless mailed to the Township Clerk for receipt at the designated time and place.

**Copies of the Bid Documents may be obtained during regular business hours from the Township Administrator’s Office at Town Hall located at 375 Millburn Avenue, Millburn NJ. A non-refundable fee of \$10.00 in the form of a check or money order payable to ‘Township of Millburn,’ is required for each complete set of Bid Documents on a compact disk. Partial sets will not be provided.**

A certified check, cashier's check or bid bond in the amount of ten percent (10%) of the bid, but in no case in excess of twenty thousand dollars (\$20,000), must be submitted with the bid guaranteeing that if a contract is awarded, the bidder shall execute the contract. Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 and all other applicable statutes, laws or regulations. Bidders are required to submit a valid Business Registration Certificate from the State of New Jersey Department of Treasury, Division of Revenue. Each bid shall be enclosed in a sealed envelope addressed to the Township Clerk, bearing the name and address of the bidder, upon which shall be designated:
